- Event Times: Event will be held on Sunday, December 11th from 5:00pm to 8:00pm.
- Holiday theme: All entries must be decorated in a "Holiday Theme". However, NO SANTA COSTUMES are
 allowed. There will be one official Santa greeting people at the event.
- Advertising: Business may advertise on a tractor or trailer. Advertising signage is limited to an area of 6 feet x 3 feet on the tractor/trailer.
- **Generators:** Participants will be responsible for generators/power supply for their tractors/trailers. All generators must be secured and kept away from any flammable materials.
- **Music:** No music is to be played from Lighted Tractors. Live holiday music will be performed throughout the event.
- **Check In:** Event organizers will be on site at Burns Park beginning at 12:00pm on Sunday, December 11th (event day) and tractors/trailers can arrive at any time after that. Tractor/trailers can be decorated once they arrive at the park, but all set-up must be completed by 5:00pm event start
- **Theme:** All participants must adhere to the event theme and must be family-oriented in nature for viewing by the general audience
- **Event Cancelation:** In the event of unsatisfactory weather conditions, the event will be cancelled. Any cancellation notifications will be made as soon as possible on the day of the event.
